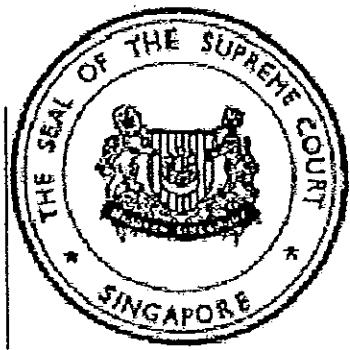

UPON the application of the abovenamed Plaintiffs made by way of Originating Summons No. 60 of 2002/F coming on for hearing on 27 March 2002 and for further hearing this day AND UPON READING the joint affidavit of the 1st and 2nd Plaintiffs filed herein on 17 January, 2002 together with the exhibits therein referred to, the affidavit of the 3rd Plaintiff filed herein on 17 January 2002 together with the exhibit therein referred to, the joint affidavit of Haron Bin Mohamed and Mohamed Noor Bin Mohamed filed herein on 7 February, 2002, the affidavit of the 1st Defendant filed herein on 26 March 2002 together

with the exhibit therein referred to, the affidavit of Abdullah Bin Joffri filed herein on 15 April 2002 together with the exhibit therein referred to, the affidavit of the 1st Defendant filed herein on 16 April 2002 together with the exhibit therein referred to and the affidavit of the 1st Defendant filed herein on 29 April 2002 together with the exhibit therein referred to AND UPON HEARING the solicitors for the Plaintiffs and for the Defendants, IT IS ORDERED that:-

1. the retirement of the abovenamed 2nd Defendant from his trusteeship and discharge of the trusts of the last Will dated 26 January 2603 (1943) of Hadjee Yousof Bin Hadjee Mohamed Noor (the "Testator"), be approved
2. Abdullah Bin Joffri (NRIC No.S0757843A) and Mohamed Idris Bin Mohamed Hanafiah (NRIC No. S0514918E) be appointed as new trustees of the said Will of the Testator to act jointly with the 1st Defendant for all the purposes in connection with the trusts of the said Will.
3. all the movable and immovable properties subject to the trusts of the said will of the Testator including the movable and immovable properties described in parts 1 and 2 of the Schedule hereto and any other assets of the Testator, shall henceforth vest in and be held by the new trustees and the 1st Defendant as joint tenants upon the same trusts and with and subject to the like powers and provisions in connection therewith.
4. the costs of the Plaintiffs be fixed at \$4,500.00 whilst the costs of the Defendants on an indemnity basis may be taxed if not agreed to between the parties hereto. Costs of both parties to be paid from the funds standing to the credit of the estate of the Testator.
