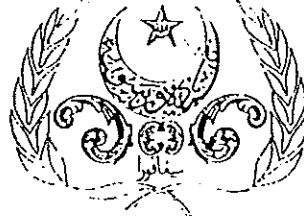

Sir,

We refer to the Land Office's letter dated 13th May 1999.

As the beneficiaries and descendants of Almarhum Sultan Hussain Shah and being the residents of Istana Kampong Glam, we wish to express our dissatisfaction to the contents of the said Land Office's letter.

The said letter is nothing more than a polite notice to evict us from our residence in Istana Kampong Glam on the assumption that the said land and the Istana Kampong Glam and the surrounding premises are now considered as State Land.

With due respect, we are of the view that there is no provision stated in the Sultan Hussain Ordinance Chapter 382 giving the power or transferability of the said land to be converted into State Land.

As such, we consider that the application under the resettlement policy signed by some of the residents of Istana Kampong Glam who are illiterate in the English Language and advanced in age is void and of no effect.

We also question the validity and correctness of the Inheritance Certificate purportedly issued by the Syariah Court of Singapore confining the heirs of Almarhum Sultan Hussain Shah supposedly to be 4 in numbers. Whereas the heirs and children of Almarhum Sultan Hussain were 5 in numbers and one of them being Almarhum Tengku Mohamad Hitam the eldest born. By omitting the name of Almarhum Tengku Mohamad Hitam in the Inheritance Certificate is as good as denying and depriving the issues of the said Almarhum Tengku Mohamad Hitam of their rights and entitlement as the descendants of Almarhum Sultan Hussain Shah to receive their respective portions of the net annual

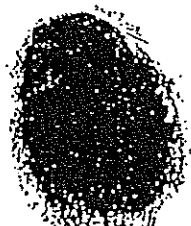

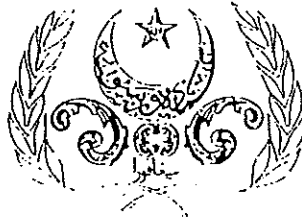
