Assignors shall **HEREBY ASSIGN** unto the Assignee all the rights title estate and interest, including any rights under any trusts, in all the property real and personal of whatever nature and wherever situate which may be due and payable to the Assignors as the beneficiaries of the Estate of the said **MOHAMED BIN HAJI YOUSOFF**, deceased.

- 3. This Assignment shall be governed by and construed in accordance with the laws of the Supreme Court of the Republic of Singapore. The parties hereto agree to submit to the exclusive jurisdiction of the Supreme Court of the Republic of Singapore.



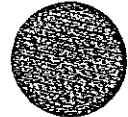
